I am delighted to continue with this weekly Candidate Update as a means to connect and share a little more of my values and skills with you. In Statement 2, I'd like to focus on the legacies we carry. As a second-wave feminist for example, I hold dear the achievements of the first-wave feminists in successfully advocating for women's suffrage. Theirs was a courageous, inspiring and hard-fought campaign. The National Library of Australia states that the first independent, self-governing nation to give all women citizens the vote was Aotearoa New Zealand in 1893. Bravo! However, recent data suggest that nation states vary in election participation. Across the board for all eligible voters, participation has been recently estimated as 71% for the USA, 66% for France and 82% for our Pacific neighbour, the Solomon Islands. By my best guess based on figures found on the RACP website, less than half of Fellows and trainees as a collective appears to have voted for significant RACP appointments in the past. Increasing participation in this election for a Board Director could be an early indicator of green shoots for effective re-engagement within our member-based College.
